

## Statement of the Moldovan National Platform of the Eastern Partnership Civil Society Forum on the Need to Ensure the Rule of Law in the Banking System

4 May 2015

The National Platform of the Eastern Partnership Civil Society Forum of Moldova has repeatedly expressed its concerns in connection with the uncertain situation related to the banking system investigation, in particular to Banca de Economii, Banca Sociala and Unibank. We consider Kroll's statements as unacceptable, unreasonable and contradicting national interests.

Stability of the banking system is a key component for ensuring security of the Republic of Moldova, the investment climate, foreign financial aid and economic development of the country. Public trust to the banking system depends on the system's compliance with legal requirements, including transparency, correctness and responsibility.

We recognize the sensitivity of the banking system to any speculation in relation to its stability, and absence of official information about actions of responsible institutions and the fact that the report of the company that performed audit of doubtful transactions was not published, will further continue discrediting the ability of state institutions to act according to their competence. Lack of state institutions' experience in conducting proper investigations can be compensated by a request addressed to relevant European institutions.

Based on the above, signatories of the present statement request:

- Publication of the full version of the Kroll company<sup>1</sup> report on the situation at Banca de Economii, Banca Sociala and Unibank;
- Publication of the contract between the National Bank of Moldova and the Kroll company. In case of impossibility or commercial secrecy issues, publication shall be provided of the part related to parties' obligations, terms and conditions of contract execution and annexes containing the terms of reference.
- Initiation of a criminal case;
- Requesting assistance from EU institutions on the establishment of an investigation mission involving European prosecutors;
- Holding responsible persons liable for governance at Banca de Economii, Banca Sociala, and Unibank, and state institutions responsible for monitoring of the financial market;
- Development of a set of actions aimed at consolidating the banking system and publication of information on them.
