## Joint statement by civil society representatives on political arrests and mistreatment of detainees in Azerbaijan

## Baku, 17 May 2013

On 30 April 2013, youth activists staged a peaceful action in Baku, Azerbaijan. Participants united around the slogan "No terror," to commemorate victims on the fourth anniversary of an act of terror committed at the Azerbaijan State Oil Academy. Police arrested Popular Front Party Youth Movement Chairman Abulfaz Gurbanli, N!DA Civic Movement Board Member Turgut Gambar, and Free Youth Organization member Ilkin Rustemzade. Gurbanli and Gambar were sentenced to 10 days of administrative detention, and Rustemzade to 15 days.

We are deeply concerned by reports of mistreatment of these individuals while in the custody of the Ministry of Internal Affairs and the Baku City Chief Police Office. Following their arrest, police denied the detainees' access to their lawyers, refused to accept food sent for them by their relatives, and forcibly shaved their heads. On 10 May, photos were distributed on progovernmental websites, showing the three activists being forced to clean while in detention, along with some derogatory comments about them.

We believe that these activists were targeted for political reasons and were illegally detained. Further, the release of the photos taken of the activists while they were in custody was illegal and constitutes a violation of their right to privacy. It was clearly intended to pressure them and other activists and to discredit them in society. The officials responsible must be identified and punished.

We emphasize that these actions are contrary to both national and international law. The Azerbaijani Constitution prohibits the mistreatment of persons in detention. Further, Article 32 provides for personal inviolability and Article 46 provides for protection of honor and dignity by the state. These principles are also contained in international treaties that Azerbaijan has joined, including the European Convention on Human Rights.

As representatives of civil society, we protest the illegality of these actions. These three young men were arrested for exercising their rights to freedom of expression and assembly. We call for those officials responsible for the violations of their rights to be prosecuted.

We further call on the international community to increase the level of attention to human rights violations in Azerbaijan in the run-up to the presidential election in October, and to exert greater pressure on the authorities to fulfill their international obligations.
