

Eastern Partnership: Objectives for Riga Summit 2015

The lead up to the 2013 Vilnius Summit and its aftermath has posed many questions regarding the European integration process of the Eastern Partnership countries. Being the driving force of continued democratic, economic and social transformations of these countries, the EU's role is becoming more important than ever. Recent developments in the region raised questions about the importance of the security dimension of the Eastern Partnership. The Crimean crisis and the 2008 Russian-Georgian War, as well as the worsening situation with the frozen conflicts in the region, indicate the need for new regional security architecture. EU-facilitated contributions to development of the Eastern Partners is not possible without addressing the security issues that hamper the EaP countries' development.

The value and transformation potential of such instruments as the Association Agreements and Deep and Comprehensive Free Trade Area agreements offered to Georgia, Moldova, and Ukraine cannot be underestimated, but the question remains: can such instruments help set these countries irreversibly on the European path and achieve deep, systemic changes in their societies? How can the EU help induce transformation in Azerbaijan, Armenia, and Belarus, where, in spite of the unfavourable environment, civil society has demonstrated the capacity to unite, mobilise, and act?

The discussion will also address the official Polish position on the future of the Eastern Partnership as well as Poland's possible role in promoting further membership perspectives for the EaP member states to other EU member states. This event brings together Polish and EU policy-makers as well as civil society actors, including representatives of the Steering Committee of the Eastern Partnership Civil Society Forum.
