Statement by the Steering Committee of the Eastern Partnership Civil Society Forum on the Release of Leyla Yunus and on Civil Society Activities in Azerbaijan

The Steering Committee of the Civil Society Forum welcomes the decision of the government of Azerbaijan to transfer the human rights defender Leyla Yunus and her husband Arif Yunus from prison to home on health grounds. We hope, that this step will be followed in the cases of other imprisoned human rights defenders and representatives of civil society in such a way that they will be able to return home and normally continue their activities.

We continue to be concerned about the imprisonment of civil society activists such as human rights defenders Intigam Aliyev, Rasul Jafarov, Anar Mammadli, journalists Khadija Ismayilova and Rauf Mirkadirov and the politician Ilgar Mammadov. We consider that the government of Azerbaijan should be interested in making a humanitarian gesture by releasing them and eliminating all obstacles to their public activities. In particular, the Steering Committee hopes that a safe space for cooperation with international donors in Azerbaijan will be re-established and cooperation between NGOs and government will be renewed.

We note that the removal of the restrictions imposed in 2014 on the projects of the organisations which were cooperating with the Coalition for Increasing Transparency in Extractive Industries proves that the government can make such positive steps without any serious consequences.

In the context of restored negotiations between the government of Azerbaijan and the European Union, the Steering Committee calls for creation of a suitable environment for the activities of civil society and deepening the relations in the direction of Euro-integration. Noting the importance of civil society's role in the reforms process, and particularly in the implementation of public oversight of the changes, the Steering Committee of the Civil Society Forum states its readiness to support civil society in Azerbaijan.
